⇒ Send this completed form and your check or money order to the above address.

- \$13.00 fee MSPCA members.
- \$33.00 fee for non-members.
- Wicketing must be certified by three (3) individual wicket officials.

☞ The definition of a wicket official:

An appointed officer of the MSPCA and or the designated wicket official of any affiliated MSPCA local club.
Officiating Judge(s) of a MSPCA Sanctioned show on the day of the show (veterinarian wicketing is not acceptable).

PROCEDURE TO BE USED TO DETERMINE HEIGHT

Section 1 must be completed prior to wicketing.

1. The Wicket Official sets the wicket at 17 “
2. The dog is placed in a stacked position by the handler, which is four-square, with the dog in a naturally alert position, the head up but not stretched upward, and with its feet under it, forelegs vertical.
3. The Wicket Official approaches the dog holding the wicket at his/her side, putting the other hand on the dog’s shoulder blades to determine where the highest point over the withers is (winkles may be moved so the wicket official has access to the correct position). Once the highest point has been established, the Wicket Official brings the wicket up quickly from behind the dog, over the dog’s back and lowers it until both legs of the wicket touch the ground.
4. The wicket crossbar is lowered to the correct position on the withers and locked in place.
5. The wicket is removed from the dog and the reading taken.
6. The Wicket Official completes the reverse side of this form under Section 2.

This procedure is repeated by a total of three (3) different Wicket Officials, and the official height will be determined as an average of the three wicketing measurements. If the dog can not be measured to the satisfaction of the wicket official, no determination can be made. All dogs must be measured with an official MSPCA wicket.
